I. Course Description

Course "Criminal Law of the Kyrgyz Republic - 2 (Special Part)" - this academic discipline, which introduces students to skills-based crimes, that is, the application of criminal law to identify - is whether a socially dangerous act is a crime or not. The special part of the Criminal Law of KR is an integral, inseparable part of the criminal law, and can act, that is used only in organic connection with the General Part of Criminal Law.

Course "Criminal Law of the Kyrgyz Republic -2 (Special Section)" aims to familiarize students with certain types of specific crimes, especially their occurrence and the penalties for committing them. The course aims to ensure that students were free to apply criminal law to qualify the crime to navigate the criminal law, be able to give a specific estimate of the socially dangerous acts.

The main textbook for this course are invited textbooks "Criminal Law of KR" (the authors - Kurmanov KN, Osmonaliev K. Tyulegenov T. et al), "Criminal Law of the Russian Federation", ed. VD Zdravomyslova, Comments to the Criminal Code (ed. Asanalieva TA, Kurmanova KN), etc.

II. Learning outcomes

- 1) Correctly classify acts (crimes) on the composition of crime.
- 2) Correctly identify categories of severity of the crime.
- 3) To differentiate between different types of crimes
- 4) To compare the crime on the severity of the damage caused to health or property.
- 5) Designing become a common part of the special part of the Criminal Code of the Kyrgyz Republic.

III. Academic rules and policies of the course

- 1. Students should come to class on time. In that case, if the teacher has already said the student as absent from the lesson, he can remain in the classroom, but would nonetheless be counted as absent.
- 2. Attendance is mandatory. In case of missing classes for a good reason, voucher must be submitted no later than the following for missed classes. If the above requirement is not met, no student will be counted as a valid reason for skipping. In

that case, if the student miss three (3) classes without good reason, or 50% of the course (for good or valid reason) for the entire course will be offered assessment of «X».

- 3. If a student was agreed to hold individual meetings (consultations) with the teacher, then visiting her necessarily. Skipping the match is regarded as a badge of official employment with all its consequences.
- 4. For all written assignments set the final deadline (deadline). In the event that a student pass the work the next day after the final deadline to 17:00 pm, the final score will be lowered by one point (for example, if the estimate for the work out of "B", in view of the rule evaluation will be "C"). After the expiry of the deadline written work will not be accepted and Evaluation in this case can be exhibited only one «F». This rule applies to all students, even in case of illness or other justifiable reason, as the dates have been set in the syllabus and all notified them in advance.
- 5. All students must follow the rules of academic honesty AUCA. All forms of cheating and plagiarism are strictly prohibited. In case of violation of this requirement when performing oral or written assignments at the discretion of the teacher of the course may be set score «F» for the job or for the entire course, depending on the particular circumstances of the case.
- 6. Mobile phones and other electronic, radio must be turned off all the time for lessons.

III. Course Requirements

- 1. Participation in seminars. Students should come to class prepared and actively participate in all training and group classes. At the seminars the student must come with the stipulation, he should know the answers to the questions provided, giving qualification of crimes in the proposed tasks, be able to handle the elements and characteristics of the offense and have notes on the topic. Seminars are held in a different form: the debate, brainstorming, problem solving, business games, etc. Written work. Throughout the semester, each student must conduct research and prepare a scientific project. Research project must be completed in writing a volume of text in a scholarly article of at least 7-9 pages 1,5-spaced, font 12 Time New Roman. By the project may be attached charts, diagrams, statistics, etc. Each project should be presented.
- 2. Requirements for students. In the classroom the student should have 2 common notebook for lecture notes and seminars. Please pay attention to the job for seminars, which provided for independent work with literature and the proposed solution of the problem. In the classroom is prohibited to take food and using a cell phone. Output from the audience only with the permission of the instructor.
- 3. Independent and individual work of students. Independent work of students includes their work in libraries and at home with the obligatory, recommended and additional literature, as well as regulations. Homework assignments may be in the form of solving problems, making logic, analytical tables, and other forms. In preparation for lectures and seminars, students should use not only textbooks but also monographs, professional literature, regulatory material and periodicals, the Internet capabilities.
