Course description

This course introduces the students with one of the four traditional fields of Anthropology - Linguistic Anthropology- as "the study of language as a cultural resource and speaking as a cultural practice". The aim of this course is to understand the crucial role played by language in the constitution of the society and its cultural representations.

Our course will be based on ethnolinguistic approach, which means all linguistic structures will be analyzed as used by real people in real time and real place. And speakers first of all are social actors of particular communities, each organized in a variety of social institutions and with sets of expectations, beliefs, and moral values about the world.

The course also introduces the students with mainstream theories in Language Policy literature and discusses its basic concepts and methods. Socio-historical and political consequences of Soviet Language Policy will be examined trough lectures and seminar discussions.

Topics include linguistic relativity hypothesis of Sapir and Whorf, Language Ideology, Language and Power, Language and moral values, Language and racism, Language and Ethnic conflict, Language and Cultural Contact, the politics of mono-and multi-lingualism etc.

Course Requirements and Grading:

Attendance and Participation (25%). Regular attendance is very important. Each unexcused absence will result in the lowering of your final grade by 2%. Each student is expected to have completed the assigned readings prior to class and to make regular, constructive contributions to class discussions.

Class presentation (25%): On the second week the students will be asked to sign up for in class presentation. The list of papers which address diverse topics in Linguistic Anthropology will be suggested by the instructor for students to read and make an individual presentation during the seminar class. The presentation should consist of both: the content of the paper and critical view of the presenter on the author's main argument.

Midterm Exam (20%): Reflection paper (3 - 4 pages). Students should choose one of three ethnographic articles, which will be recommended by the instructor, and write a reflection paper on it. A reflection Paper should provide critical view on how author formulated the main argument, what examples and cases were used by the author to discuss the main question. How all evidences were interpreted in relation to particular context and in connection with other secondary sources? You are also encouraged to find connections of the paper with modern events and themes.

Research Project (30%): (due to the last class). For this course students are expected to do a library or field research that will be focused on the relationship between Language and Society in one of Central Asian countries. The purpose of this assignment is to give you an opportunity to explore in depth a topic you have found interesting. The project should consist of the following parts: research question, research hypothesis, literature review, research argument, analysis of collected data, conclusion and bibliography. Make sure you understand the appropriate use of sources in your work and be informed that plagiarism will result in zero grade for the course. Research paper (8-10 pages) should be typed and double spaced.
